

GRANTS AVAILABLE FOR UP TO A STUDENT'S PELL ELIGIBILITY

(For Students in the Bachelor of Science in Business Administration Program)

Beginning with the December 2016 subscription period, newly admitted UW-Extension Flexible Option students who demonstrate financial need as determined by completing the UW Flexible Option Tuition Grant application may be eligible for a tuition grant of up to \$2,250 per [subscription period](#). This eligibility is fully dependent on demonstrated financial need and the student's ability to make reasonable progress completing the projects or competency sets in which s/he enrolls. This grant is temporarily available to eligible students until UW-Extension is eligible and able to distribute federal financial aid, and is subject to change at any time.

Students must complete the UW Flexible Option Tuition Grant application and provide documentation of income to be considered.

Application Process

To be initially eligible for a UW Flexible Option tuition grant, a student must:

- Complete the UW Flexible Option Tuition Grant Application.
 - The priority deadline for application is one month prior to the start of the subscription period. For example, if a student is beginning a subscription period on March 2, s/he must apply by February 1st. Applications received after the priority deadline may not be processed by the student's subscription period [payment deadline](#).
 - Eligibility is based on total household income.
 - Students must be citizens or eligible non-citizens of the United States to qualify.
- Be newly admitted to enroll in or to start the UW-Extension Bachelor of Science in Business Administration Flexible Option degree program for the December 2016 subscription period or later.
- Do not submit a FAFSA. At this time, the Bachelor of Science in Business Administration program is not currently eligible for federal aid. NOTE: Once federal financial aid for UW Flexible Option programs becomes available through UW-Extension, the tuition grant will no longer be available.

Continuing eligibility

In addition to the initial eligibility criteria, students must demonstrate successful progress to the degree.

- Students who received the grant must complete (demonstrate mastery) at least 6 credit hour equivalencies within the subscription period.

Warning Status

Students who do not demonstrate academic progress will be given a one-time grace period or warning status. They will remain eligible for the grant for one additional subscription period. Failure to demonstrate progress in a warning period will result in loss of eligibility for the UW Flexible Option Tuition Grant.

In-Progress Mark or Grade (IP)

An In-Progress Mark or Grade reflects that the student has yet to demonstrate mastery for all competencies in that project or competency set, and must re-enroll if s/he wishes to demonstrate mastery in that project or competency set. Projects or competency sets for which a student is re-enrolled in due to the receipt of an In Progress Mark or Grade are not eligible for the grant.

Withdrawals

A project or competency set that is dropped after the 10th day of the subscription period will not result in loss of a tuition grant for the subscription period in which it was received. However, it could impact continued eligibility for future subscription periods.

Receipt of financial assistance during one or more periods shall not guarantee continued or future assistance.
